This is a prerequisite for individual support of the child. For this reason, the provider or the contracted specialist staff are obliged to have the parents / legal guardians provide proof of the child's participation in the last age-appropriate screening examination at the time of admission. We would like to point out that the Measles Protection Act will come into force on 01.03.2020. For this reason, the provider or the contracted specialist staff are obliged to have the parents present proof of vaccination or proof of the child's immunity to measles upon admission.
